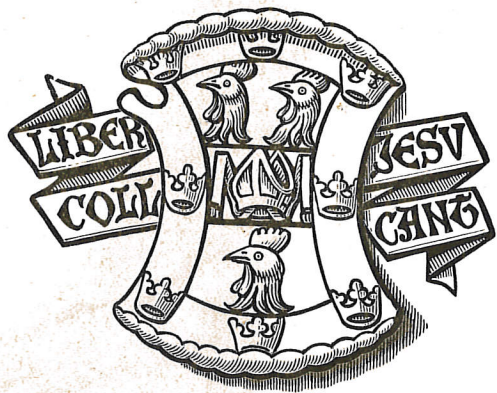

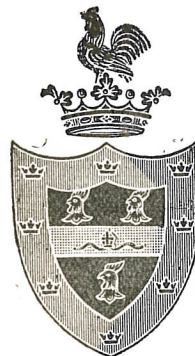

R U L E S .

1. The Society shall be composed of matriculated Members of Jesus College, Cambridge, and be called "THE JESUS COLLEGE CAMBRIDGE SOCIETY."
2. The objects of the Society shall be :—
 - (a) To encourage intercourse between old Jesus men, and to keep them in touch with the College and its doings.
 - (b) To publish and circulate amongst its Members an Annual Report, containing a list of Members with their addresses, and all news of interest about the doings of the present and former Members of the College.
 - (c) To ensure the permanence and success of the Jesus College Dinner, held annually in London on the first day of the Inter-University Cricket Match, and to pay the incidental expenses thereof.
 - (d) To forward the interests of any College institution.
3. Every matriculated Member of the College shall be eligible for election to the Society, and

upon election and payment of one guinea shall become a Member of the Society, without being liable to any further expense.

4. The Officers of the Society shall consist of a President, a Secretary, and a Treasurer. The Master of the College shall be the President. In the event of a Vice-Master of the College being appointed, he shall become Vice-President. The Secretary and Treasurer shall be elected at the Annual General Meeting.

5. The management of the Society and the election of Members shall be vested in a Committee, consisting of the President, Vice-President, Secretary, Treasurer, two resident Fellows of the College nominated from time to time by the Master and Fellows, and sixteen elected Members. At the Annual General Meeting one-fourth of the elected Members of the Committee shall retire from office. The retiring Members shall be those who have been longest in office since their last election, and amongst those of equal seniority the choice, in default of agreement, shall be made by ballot. The vacancies so created shall be filled up at the same Meeting by a majority of the votes of those present and voting. Casual vacancies may be filled up by the Committee, subject to confirmation at the next Annual General Meeting. A Member elected to fill a casual vacancy shall retire at the time when the Member whose place he fills would have retired.

6. The administration of the funds of the Society shall be vested in the Committee, who may invest or otherwise deal with the same for the objects of the Society as they in their discretion may think fit. All investments shall be made in the names of three Trustees to be appointed by the Committee.

7. The Committee shall meet as and when they may from time to time determine; five to form a quorum.

8. The Annual General Meeting of the Society shall be held in London or Cambridge on a day to be fixed by the Committee. At least fourteen days' notice of the Meeting shall be given by the Secretary in such manner as the Committee shall from time to time direct.

9. The Annual Report, containing a list of Members with their addresses, and all news of interest about the doings of the present and former Members of the College, shall be edited by the two resident Fellows who are Members of the Committee, in conjunction with the Secretary, and shall be sent to every Member of the Society.

10. The Committee in their discretion may, and, upon a written request signed by fifteen Members of the Society, shall call a Special General Meeting, the time and place for which shall be determined by the Committee. At least fourteen days' notice of such

Meeting, stating the subject, shall be given in such manner as the Committee may direct.

11. If it appear to the Committee that the conduct of any Member of the Society is such as to render him unfit to remain a Member thereof, it shall be in their discretion to call a General Meeting to deal with the matter, and, in the event of its being decided at that Meeting by two-thirds of the Members present and voting that such Member be expelled from the Society, he shall thenceforth cease to be a Member and forfeit all right to or claim upon the Society or its funds.

12. The Rules of the Society may be altered, but no alteration shall be made except at a General Meeting and by a majority of two-thirds of those present and voting, and unless notice of the proposed alteration has been stated on the notice calling the Meeting.

REPORT OF THE EVENTS OF THE YEAR

1910—1911.

On the occasion of some International Exhibition, in the cheerful section devoted to what used to be called education, but is now styled pædagogy and will doubtless one day be promoted to the dignity of an ology—epistemology having been bagged by the moral scientists we humbly suggest anagogology—the College was asked to contribute to the mural decorations two diagrammatic charts indicating (A) the annual brain-efficiency since its foundation, and (B) the material increase or decrease in numbers. To what the Society agreed on the first we forget. We think they allowed the managers to provide it at their own expense, which they refused to do. As to (B), it was ignored because the entry showed a tendency like the barometer when all the cones are hoisted on every coast. Now the Master and Fellows are in no such case, and could gladly provide the said “diagrammatic chart (B)” to indicate the present prosperity of the College. In other words, the entry is a subject of little anxiety to anyone except those who fear they may not be admitted. As to “diagrammatic chart (A)” the intellectual excellence of the

latest Fellows promises to send the green line, adopted for the purpose, up to such a pitch that an extra sheet will have to be gummed or pinned on to the new chart. To adopt the language of common life, which is always difficult where education (especially elementary) is being discussed, we are all right.

What may happen ere the Report appears it is impossible to say, but one thing is certain, and that is that a Jesus crew has crossed the Channel and beaten the Belgians. From all accounts the *braves Belges* have given them a glorious reception, and we wish we had the chance of giving our gallant opponents the opportunity of gauging the quality of our College hospitality. The first boat has had the benefit of Mr. Spencer Gollan's help, who, in the true Jesus spirit, left his home to spend three weeks in coaching his old College. The illness of Mr. S. Fairbairn, from which we all wish him a speedy recovery, has handicapped us sadly, but there is yet a hope that he may contribute to our success.

The Master's health has, we are thankful to say, been maintained, and though he is not able to get about much, his cheerful spirit is as indomitable as ever, and his interest in all that goes on is unabated. It is superfluous to add any assurances as to the great value he is to the College, which feels constantly encouraged by the sympathy with its welfare which radiates from the Lodge.

The following statistics show that in point of numbers the College has continued to flourish. In October last, with an entry of seventy-five freshmen, the number of men *in statu pupillari* rose to two hundred and seventeen, probably a record in the history of the College. But counting those only who are actually in residence this term, the freshmen number seventy-five, the second year fifty-four, the third forty-nine, the fourth year undergraduates eight; there are thirteen B.A.'s, and twenty-five Jesus men above that degree reside in Cambridge as members of the electoral roll, in addition to two residents who are not yet on the roll. Thus the total number of residents *in statu pupillari* is one hundred and ninety-nine as compared with one hundred and ninety-two, the figure in the May Term of 1910.

Obituary. Almost the oldest member of the College passed away in the person of the Rev. Robert Godolphin Petre, who died at Canterbury, aged ninety-two, on October 14th, 1910. He graduated as fourth Classic in 1842. Mr. Osmond Fisher, to whom is due the uncovering of the Chapter House door in the Cloister Court, had taken his degree in the previous year, and survives Mr. Petre. The first class in the Classical Tripos of 1842 included Dr. Atkinson, the present Master of Clare; H. A. J. Munro, the editor of *Lucretius*; and Charles Kingsley. Mr. Petre was ordained in 1845, and became a Fellow of the College in the following

year. After ten years spent at Canterbury as Curate of St. Mary, Northgate, and Rector of St. George the Martyr with St. Mary Magdalene, he returned in 1858 to Jesus College as Tutor, but in 1860 accepted the College living of Cavendish, in Suffolk, where his kindly disposition and courtly manners endeared him to his parishioners. He was for some years Rural Dean of Clare, and retired from his living in 1895.

Jameson John Macan, M.A., M.D., died at Cheam, aged sixty-five, on October 16th, 1910. In Dr. Macan the College loses a man of distinction in his special subject, and a patriotic adherent, who was a familiar figure at old Jesus men's dinners, and on the Committee of the Jesus College Society. He was the second son of the late Hon. Judge Macan, of Dublin, and brother to the present Master of University College, Oxford. He graduated as a Senior Optime in the Mathematical Tripos of 1867, and, if the present writer's recollections are correct, was a member of a very successful second May boat. Proceeding to St. Bartholomew's, he became M.R.C.S. of England in 1870. Early in his career he held various appointments under the Government of Victoria, Australia, and later on settled in Rockhampton, Queensland. In 1884 he took the Cambridge Diploma of Public Health, and proceeded to the degrees of M.A. and M.D. ten years later. He was at one time editor of the *British Gynaecological Journal*, and from 1907-09 was assistant editor of the *Journal of Obstetrics and*

Gynaecology of the British Empire. He wrote various treatises and articles on Gynaecology, and had translated from the German a work of Prof. Schultze on a branch of that subject. On the Committee of the Jesus College Society he represented the year that came up in 1863. His fine presence and voice and his geniality will be missed by many who have attended the old Jesus men's dinner in recent years.

The Very Rev. Benjamin Stannard Fryer died, aged forty-eight, on October 5th, 1910, from the effects of an accident, in which he had suffered a broken leg a few weeks earlier. He took his degree in 1883, in which year he also rowed 7 in the second May boat. Ordained in 1886, after being trained at the Ely Theological College, he served curacies at St. Mary's, Ely, and at Long Melford. In 1893 he was appointed Vicar of St. Gregory with St. Peter, Sudbury, and in 1901 Rector of Rougham. Only a year before his death he was chosen by the Archbishop to be Rector of Hadleigh, a position which carries with it the Deanery of Bocking.

Philip Sidney Kesterman Joyce died at Woking, aged forty-three, on June 22nd, 1910. Educated at St. Paul's School, he came up in 1886 as a Classical Scholar, taking a second class in the Tripos of 1889. He will be remembered by his contemporaries as a dashing bat in the eleven that included McGregor,

Woods, and the present secretary of the Jesus College Society.

George Mortimer Gwyther, M.A., was an Assistant Master at Plymouth College, and a former scholar of Jesus, where he came into residence in 1887. The following notice has been kindly communicated by Mr. F. H. Colson, of St. John's, under whom Mr. Gwyther served at Plymouth: "Gwyther (who had been my pupil at Bradford) joined my staff at Plymouth directly after taking his degree in 1891, and remained there all his life. He was a very valuable master and had a considerable reputation not only in the school but in the town. He was originally appointed as a classical and English master, but afterwards turned his attention specially to history. As a history teacher he was entirely successful, and two of his pupils gained very good scholarships at Oxford. A year or two ago he submitted the notes he had made for teaching to his class to Messrs. Longmans, who at once offered to publish them under the title of *English History in the Classroom*. He also wrote two small editions of Cæsar, Book III, and Euripides' *Bacchæ* for Messrs. Bell. He was a very active member of the Association of Assistant Masters and also of the National Association. He was a member of the committee of this last. He made a considerable study of the science of education, and in 1904 obtained a diploma with distinction in it from the University of Oxford. He was particularly successful

in training boys for singing and acting, and the comic operas produced at Plymouth College under his direction were a very remarkable success. He had a painful illness of some eight months, and died just before Christmas. He married in 1901 Miss M. Shakespear, who survives him. He had no children. There were many signs of general regret and respect at his death."

Arnold Chevallier Aldous died on the 25th February, 1911, aged 27 years. He came of a family of which several members have been or are to be connected with the College. His father, the Rev. J. C. P. Aldous, now Rector of Sywell, Northamptonshire, and at one time Chief Instructor on board the *Britannia*, was formerly a Fellow of Jesus, and an elder brother was a mathematical scholar and boat captain in 1902. His younger brother comes into residence as a Classical Scholar next year. A. C. Aldous came up from Repton in 1902 as Senior Classical Scholar. He was a man of marked individuality, possessed of great determination and force of character; he ultimately decided to take his Tripos in his second year and go down. Taking up land in Canada, he spent years of the most strenuous toil and exertion in converting his estate of hitherto untouched soil into a farm, and in so doing no doubt overtaxed his strength. Since his return to England he had never been really robust, and the end came after a short illness. Those who remember him at

College or who knew his father or brother will lament the premature death of a man of so sterling a character.

We regret also to have to record the deaths of the Rev. William Brice Gray, M.A., Vicar from 1879 to 1907 of Kersey, Ipswich, and Cricket Captain in 1872; and of the Rev. John Waller, M.A., one of the founders of the College Musical Society. Ordained in 1883, he served curacies at Dorking, Folkestone and elsewhere, and at the time of his death was licensed to officiate in the diocese of Chichester.

Fellowships.

The loss of Dr. Inge is tempered only by the sense of the honour his promotion to the Deanery of St. Paul's is to his College. His work as a Professor is the property of the University, and we must content ourselves with saying that in his all too short tenure of the office he has raised the school in the estimation of all and will rank among the greatest of his distinguished predecessors. We hope that his uncompromising adherence to his principles will not prevent his acknowledging that in four brief years he has become a thorough Jesuit, and that, once admitted to our order, it is not possible to sever himself from us. He certainly carries with him our good will to his home in the City of London.

Until recently it was impossible for the College either to elect anyone to hold a Fellowship for a less number of years than six, or to re-elect to a Fellowship that had lapsed; but by a statute lately obtained both these procedures are permitted, re-election being allowed in case of great distinction for learning, science, and so forth, and also if the person re-elected is required to serve on the staff of the College. The first appointment under this new statute was made in March, when G. H. Livens, B.A., was elected a Fellow. A scholar of the College, hailing from the Latymer School, Hammersmith, he was bracketed fourth Wrangler in 1909, and next year was placed in the second division of the first class, Mathematical Tripos, Part II. A few days after his election came the announcement that he had gained the First Smith's Prize for an essay on "The Influence of Density on the Position of the Emission and Absorption Lines in a Gas-Spectrum." This distinction has not fallen to a Jesus man since it was won by Mr. Welsh. Mr. Livens has recently been acting as Chief Assistant to the Professor of Mathematics in the University of Sheffield.

Mr. W. H. Duke has been made Assistant-Lecturer in Classics.

Mr. A. J. Wyatt, of Christ's College, has been appointed Director to students in Mediæval and Modern Languages.

In 1910 First Classes were obtained in the various Triposes as follows: Mathematical Honours. Tripos (old regulations), Part II, G. H. Livens, B.A., in the second division; under the new regulations, Part I, W. W. Fletcher; Part II, E. N. Lovell; Classics, Part I, H. Farrell and E. M. W. Tillyard, in the third division; Natural Sciences, Part I, H. L. Cronk and J. S. C. Reid; Theological, Part I, H. V. Edmunds, B.A.; and G. S. Redman, B.A., with distinction in New Testament; Part II, E. Levine, B.A., with the Hebrew Prize; Law, Part II, M. E. H. Schiff.

The following University distinctions have been won in the course of the year: First Smith's Prize, G. H. Livens, B.A., Fellow of the College; George Williams Prize, Rev. B. T. D. Smith, M.A.; Carus Greek Testament Prize for Bachelors, G. B. Redman, B.A. (bracketed equal); John Winbolt Prize, A. B. Eason, B.A., for an essay on the "Ignition Temperatures of Gases"; second Jeremie Septuagint Prize, H. V. Edmunds, B.A.; *proxime accessit* for Members' English Essay Prize, J. H. Allen, B.A., LL.B.

G. B. Redman, B.A., was elected to a Nadin Divinity Studentship at St. John's College.

In the examination for the Home and Indian Civil Services, H. R. Scott, B.A., was placed eighth, obtaining the highest marks in two of his subjects; F. W. Scott, B.A., and T. Austin, B.A., were

respectively fiftieth and eighty-seventh; H. M.-M. Moore, B.A., gained an Eastern Cadetship.

The following were elected to entrance Scholarships. Scholarships in December last : G. E. Cuffe, Marlborough College, £60 for Mathematics (Rustat); H. G. Vincent, Haileybury College, £60 for Mathematics; A. E. Aldous, Repton School, £60 for Classics (Rustat); H. D. L. Minton, Horsham Grammar School, £60 for Natural Science; J. P. Moffitt, Bede Collegiate School, Sunderland, £40 for History; G. G. Webster, Charterhouse, £40 for Classics (Rustat); J. J. Loewe, St. Paul's School, £40 for Classics.

On the results of the College Examinations in June 1910, S. Wadsworth and E. J. Bradley were elected Scholars.

Lady Kay Theological Scholarships were awarded to H. F. Kirkpatrick, B.A.; and to H. E. Wynn, B.A., of Trinity Hall.

Entrance Exhibitions were awarded in December to—W. J. G. Hands, Bournemouth School, £40 for Mathematics; G. M. Bradley, Dover College, £30 for Classics; G. Y. Loveband, Eastbourne College, £30 for Classics; T. A. C. Rubie, Rossall School, £30 for Classics; I. A. Mack, The Leys School, £30 for History.

On the results of the College Examinations in June 1910, an Exhibition was awarded to C. P. Miller.

In the course of the year, the Rev. A. Lukyn Williams, B.D., has proceeded to the degree of D.D., and Mr. B. Halley Stewart and Mr. A. S. Morton Palmer to that of M.D. Up to the present time of writing sixteen members of the College have taken their M.A. degrees.

The College provides this year two Tripos examiners, the Dean in Part II. Mr. H. G. Wood in Part I, of the Theological Tripos. Dr. Duckworth is examining for the Second M.B.

Mr. F. W. Green has been appointed Honorary Keeper of Egyptian Antiquities in the Fitzwilliam Museum, and Mr. J. Hewitt Curator of the Government Museum at Grahamstown, South Africa.

Mr. H. J. Priestley, recently Assistant Lecturer in Mathematics at Manchester University, is now Professor of Mathematics and Physics in the new University of Brisbane.

Mr. Frederick John Jackson, C.B., C.M.G., was appointed in March last to be Governor and Commander-in-Chief of Uganda. Mr. Jackson, who was born in 1860, and came up to Jesus from Shrewsbury, had since 1907 been Lieutenant-Governor of the East Africa Protectorate.

Mr. R. S. Wood, Assistant-Master at the High School, Nottingham, has been appointed to an Inspectorship of Schools.

The Rev. T. G. Gilling Lax, M.A., formerly Vicar of St. Thomas', Stourbridge, has been presented to the vicarage of Orpington, Kent; and the Rev. F. W. Fulford, M.A., to the Rectory of Turvey, Bedfordshire.

E. G. S. Cane, B.A., has been gazetted to the Royal Army Medical Corps.

W. H. J. Thornton obtained a commission as a University Candidate in the Royal Artillery.

Parliament. At the last Parliamentary elections five members of the College were successful in their candidature, namely: Mr. A. C. Beck, Liberal, Saffron Walden; Mr. P. H. Illingworth, Liberal, returned unopposed for the Shipley Division of the West Riding; Mr. R. J. N. Neville, Unionist, Wigan; Colonel E. Pryce-Jones, Unionist, Montgomery Boroughs; and Colonel R. F. Ratcliff, Unionist, Burton Division of Staffordshire.

Mr. Illingworth has been promoted to the position of second Government Whip, and Mr. Beck appointed Parliamentary Private Secretary to the Secretary of the Board of Trade.

To Mr. P. M. Thornton, ex-M.P. for Clapham, who did not stand at the last elections, a testimonial

in recognition of his services was presented by his former constituents.

The Lent Term in Cambridge was enlivened by the election of a "Burgess to serve in Parliament for the University" by reason of the lamented death of Mr. S. H. Butcher, one of the two recently elected members. Mr. Harold Cox was put forward by a strong Cambridge Committee, on which the Vice-Master took an active part, and was supported by an influential Committee in London. He was early in the field, but the "official" candidate of the Conservative party in Cambridge was Sir Joseph Larmor, of St. John's. In the correspondence which the election produced in the *Times* and other newspapers, the Vice-Master, the Dean, and Mr. Watt took no small part; but Mr. Balfour's decision to support Sir Joseph Larmor no doubt carried great weight. In the result, the "official" candidate obtained 2,308 votes, Mr. Cox 1,954, and Mr. T. E. Page 332. Mr. Cox is to be congratulated on the excellent fight that he made.

Memorial of Cranmer. The contributions promised towards the Cranmer Memorial amount to well over £300, and steps have now been taken to proceed with the work. The Committee has decided that

the Memorial shall take the form of a medallion portrait of Cranmer, to be set up in the Chapel, and has entrusted the commission to Mr. Bruce Joy, who is about to submit designs.

A slight addition to the College buildings has been erected in the shape of a much-needed extension of the Buttery, projecting into Pump Court. In the colour of its bricks, and in general appearance, it harmonises so well with the existing buildings that many have failed to notice it.

We understand that steps were recently taken in North Staffordshire to ascertain the names of all old Jesus men who were residing there. The result was very successful, as 17 old members of the College were run to ground.

On Monday, 20th February, Mr. J. R. B. Masefield arranged that a number of these old Jesus men should dine together at The North Stafford Hotel, Stoke-on-Trent. The eight who ultimately met were: The Revs. H. A. Arnold, H. M. Fowler and I. Goodacre, and Messrs. Masefield, Norris, Bowers, Grogan and Lewis.

Mr. Masefield was voted to the chair, and a most enjoyable and festive evening was spent. Before sitting down to dinner the following telegram was despatched to the Master: "Greetings from eight old Jesus men dining together; good luck to the old

College." And to this the kind reply was received: "Warmest thanks for kind greetings; most heartily reciprocated by self and College."

"The King" and "The College" were the only toasts drunk, and in proposing the latter the Chairman recalled many old reminiscences of the three happy years he spent at the College (1869-1872). He said he was the first inhabitant of "O" staircase in the first block of new buildings added to the College in 1870. Only the Choir of the Chapel was used then for services, and accommodated all the members of the College. Besides rowing, cricket and athletics, a favourite amusement then in the College was "quoits." Tennis and golf were unknown, and very little football was played. There had been three members of the College bearing his name—two brothers, and a son of one of them—and all three rowed in the first Jesus boat. Reference was also made to an outbreak of fire in the top set of rooms in the staircase next to the Chapel, although smoke was first observed coming from behind the wainscotting of a ground floor room; the real cause of the fire was a beam passing under the hearthstone in one of the top rooms of the staircase. The outbreak was fortunately got under before much damage was done, except by water, and the hasty clearing out of the furniture of the rooms under the direction of the Dean, the Rev. E. H. Morgan. The chairman called upon Captain Grogan, of African explora-

tion fame, and one of the builders of our Empire, to respond for the College.

* Captain Grogan, in a most interesting and able speech, said that on his travels he had met with old Jesus men in almost all the countries of the world, and they had had no small share, especially in Australasia, in building up our great Empire. He concluded by thanking the Chairman, on behalf of all present, for organising the dinner, and threw out a suggestion that other counties should take steps to organise old Jesus men with a view to their becoming better acquainted, and especially to get them to join the Jesus College Cambridge Society, and to make a special effort to attend the Annual Jesus Dinner in London.

Rowing. Last year's Report related the performances of the boats in the then recent May races, in which we finished head, tenth and twenty-fourth on the river.

It was hoped that the crew sent to Henley would be the same as that which rowed head of the river; but owing to the indisposition of H. C. Hudson this was found to be impossible, and the boat was finally re-arranged in the following order:

The crew made considerable progress under the guidanceship of Mr. Steve Fairbairn, who most kindly managed to come over from Slough every day, and coached throughout with untiring energy.

About four days before the races the crew underwent another change, and H. E. Swanston, who was acting spare man, had to come in at "5." Swanston had been practising for the Goblets with Mr. Fairbairn, and so was able to settle down immediately to hard work, and imparted added "life" to the boat in its finishing stages.

In the heat against Balliol for the Ladies' Plate Jesus failed to strike anything approaching their true form, and never gave themselves a chance of settling down. Balliol rowed with a strong, clean drive carried finely through to the finish, and it is unsatisfactory that Jesus should have failed in this race to produce that "draw away" which reflects so surely the well-timed "beginning," and which is such a characteristic feature of our best crews.

In the first heat, against Thames R.C., for the Grand Challenge Cup, one could hardly realise that the crew that raced Thames was that which had "scrapped" over the course in the wake of Balliol the day before. Thames were fast off the mark, but Jesus well held their own, and were only led by a quarter of a length when clearing the Island. This position was kept until nearing the bend, when Jesus

went a quarter of a length in front, which was increased to a half at the mile post. From this point, however, Thames, taking advantage of the slack water on the Berks shore, and by a series of very fine spurts, began to gain ground, until fifty yards from the finish both crews were level, and racing neck and neck. Then Fairbairn, spurting in his own inimitable manner, forced his crew inch by inch ahead, and finally shot the post with a lead of two feet.

In the semi-final, Jesus, although led at the start, had a much easier race than that of the day before. After reaching Fawley, a quarter of a length "down," Jesus began rapidly to overhaul London R.C., and in thirty strokes were a length to the good. This advantage was easily held to the finish, the official verdict being given as "a bare length."

In the final Jesus met one of the finest crews that have been seen at Henley for some time. In the first minute Magdalen rowed 44 strokes to our 41, and led by half a length when clearing the island, which increased to one and a quarter lengths at the half-mile. Spurting on the corner Jesus managed to decrease the lead to three-quarters of a length. Magdalen, however, gradually drew away again, and passed the post with a lead of two lengths.

This row was a long way ahead of any other work done by the crew, who never lost their form, and had

the satisfaction of knowing that they were beaten on their best performance.

For the coxswainless fours, a crew in the order of Jerwood, *Stroke*, Goldsmith 3, Pattinson 2, Manifold, *Bow*, carried out a week's practice, before term, on the Thames.

The crew did not come on as fast as it should have done, and lacked life and firmness. Mr. Fairbairn again very kindly made a point of taking the boat for at least one of its outings every day, and under his coaching everyone made a great deal of individual improvement, and gained a large amount of very valuable experience.

At the beginning of term several days were spent on deciding the crew finally, during which time Dr. Foakes-Jackson was kind enough to give his valuable advice, and the crew eventually decided on was :

Mr. Fairbairn was unfortunately only able to come up for two days, and his presence on the bank was sorely missed by the crew, whose progress was very much handicapped by the lack of a permanent coach. P. G. Van der Byl at the beginning of practice, and Dr. Foakes-Jackson at the end, gave

the crew a great deal of valuable help, but even the very best of casual coaches cannot quite take the place of a permanent one.

In the first round of the races Jesus drew Emmanuel. Starting at rather too slow a stroke, Jesus were slightly down at First Post Corner, and owing to bad steering at Grassy still further lost ground, and in the Plough Reach Emmanuel had a lead of two lengths. On rounding Ditton, however, Jesus, rowing a slower but longer stroke than their opponents, gradually decreased the lead, and eventually won a good race by about ten yards.

In the second round Jesus met First Trinity. Jesus started more smartly than on the previous day, but were nevertheless two-and-a-half lengths down at the Plough. This lead was reduced slightly after Ditton, but First eventually reached their post about two lengths ahead.

We only had one representative in the Colquhouns, L. A. Pattinson. He reached the semi-final, and was only beaten by half-a-second by S. E. Swann, who was the ultimate winner.

In the Lent term the first boat came up according to their custom a week before the rest of us. But in contravention of their usual practice, they did not waste several weeks of the term in ringing changes with the order. That the crew was well-chosen is evident from the result. The boat was coached all

along by the captain of the boat club, though on several occasions he had the valuable assistance of Mr. F. G. Hudson, who has helped to produce so many successful Lent boats.

The first boat never gave its supporters any serious anxiety during practice, and in the races it well sustained its reputation. In fact, so far did it out-distance the boats below it each night, that there is little to be said in describing the separate nights' racing. Probably the last night gave the finest exhibition of their pace; it is no mean feat to cover your water in rowing the Reach against half a gale.

Unfortunately we cannot report the same success of the second boat, as they lost three places during the races. Their best row was on the third night, when they allowed Caius II to come within a few feet of them in the Plough, and then from Ditton onwards drew gradually away. It was a very fine race for the spectators. The crew suffered from lack of weight and experience.

The third boat were a disappointment in losing two places, as in practice they seemed quite one of the best boats in their division. But as so often happens in the case of a crew of young oars, nerves and inexperience spoiled them in the races. They had very bad luck the first night in not getting Emmanuel III. For no doubt a bump then would

have given the necessary fillip to make them ascend yet higher.

Owing to mishaps, no crew was finally entered for the Clinker Fours.

In the 'Varsity boat we were represented by Eric Fairbairn at 7 and C. A. Skinner as cox.

The outlook for the Mays at the beginning of this term did not seem particularly brilliant. Only two of last year's May boat were in residence, and under the circumstances it was decided not to send in any entries for either the Magdalene Pairs or the Lower Double Sculls, but to concentrate all attention on the

May boat. Thus the crew was able to get together without the numerous changes which are usual during the first few weeks of practice. Except for the inclusion of the Captain at 6 after about ten days of practice, the order of rowing remained unchanged. For a few days at the beginning of term the first boat was coached by Dr. Foakes Jackson, and on May 11th he was relieved by Mr. Spencer Gollan, who did a very great deal for the crew. He believes in plenty of hard work, and coached especially for smartness and life at the beginning. Our hopes of welcoming Steve Fairbairn on the towing-path were doomed to disappointment, but Mr. F. G. Hudson gave valuable help. The second boat was coached by Mr. Howard and Mr. Elliott, and the third boat by J. H. Goldsmith.

Briefly to chronicle the results of the racing, the first boat suffered two bumps from First Trinity and Pembroke. On the third and fourth nights, however, though hotly pressed and occasionally overlapped by Trinity Hall, they averted defeat by a most plucky exhibition of rowing. It was agreed on all hands that our success was due in the first place to Skinner's admirable steering and tactics, and in the second to Jerwood's able stroking and the grit of the whole crew. The second boat rowed over all four nights, and the third lost four places. Thus the three boats finished respectively third, tenth and twenty-eighth on the river.

J. C. B. C. v. ROYAL CLUB NAUTIQUE DE GAND.

There was some surprise, and not a little jeering, in rowing circles when it was announced that a Jesus crew had determined to go to the Continent and row the renowned Belgian oarsmen on their own waters at Ghent.

The Belgians had established a big reputation by their doings at Henley. On three recent occasions had they won the Grand, and their style and success were talked of everywhere where rowing men were collected. They had repeatedly issued invitations to British crews to come and row them on their own

course, but it was left to Jesus rowing men to take up their friendly challenge.

The following crew were selected, and began practising at Putney on March 20th :—

It had been hoped that Mr. Steve Fairbairn would be able to coach the crew; unfortunately, his health did not allow of this, and Mr. S. M. Bruce kindly consented to take charge of them. Later on the crew moved to Richmond and boated from Messum's, putting up at The Pigeons Hotel (W. G. East's), and on May 17th they took their first row on the Canal at Ghent. At Richmond their rowing did not appeal to some authorities, but after their arrival in Belgium they came on by leaps and bounds, and no praise could be too great for the condition in which Bruce brought them to the post on the day of the race.

The people of Ghent had for weeks been looking forward to the coming of the Jesus crew, and had determined to make their visit a pleasant one. For

days before the race the city was decorated with flags, and large streamers were stretched across the streets announcing that the great race would take place on May 25th.

On the day of the race itself, the crew on a 'bus, and their friends following in carriages, drove through the streets of the city decorated with hundreds of flags to a quay, where they boarded a launch kindly placed at their disposal by the owner, and made a royal progress down the canal to the course.

The canal is a wide one, quite straight, and capable of taking as many as six racing-boats abreast. The depth of the water is 24 feet and over. There is a slight stream, but altogether it formed a perfect course for a race.

On their arrival at the scene of action, and after a preliminary practice, the crew and their friends were entertained at lunch by Mr. Lippens, who throughout the whole visit was most untiring in his endeavours to make the crew happy, and most successful.

At lunch were also assembled Sir A. Hardinge, K.C.B., the British Minister, Sir Cecil Hertslet, the Consul-General, and many of the principal people of Ghent.

Afterwards, and before the great event, it was possible from the top of the bank to get some idea

of the enormous crowd that had collected. They thronged both sides of the canal, and were variously estimated as numbering from 100,000 to 150,000. There were also a large number of boats and private yachts on either bank of the canal; but no boats were encouraged to move about, so that a clear course was always kept.

The Terdonck Bridge was decorated, and bore the word "Welcom." This had been done by the villagers, who had asked to be allowed to show their appreciation of the English visit.

There were other items on the regatta programme, but they were only of local interest. As the time for the race approached the excitement increased. The Jesus crew, as challengers, were first afloat, and after a slight delay they were joined by the Belgians. At 4.30 the race began.

THE RACE.

The Belgians started at 41, the Jesus crew about two strokes slower, but in spite of some splashing in the Jesus boat they at once began to gain. Halfway over the course the Jesus crew were rowing at 35, the rowing being clean and powerful, the blades well covered, and the boat running beautifully. They were half a length clear at this point, and gaining gradually they finished, according to the official fiat, two lengths to the good.

The Belgians rowed in their usual style—a powerful, uniform leg drive, a shortish swing and a clean feather. But the Jesus boat was an example of English rowing at its best, and in the opinion of the *Field* correspondent—a well-known old Blue—"a better class than that of either U. B. C. of this year."

The length of the course was the same as at Henley, and the time of the race—6 mins. 43 secs.—would therefore appear to be a record. But the depth of water and absence of stream made the circumstances at Ghent possibly a little more favourable. Still, the race was undoubtedly fast—very fast.

Probably never before has the success of a foreign crew been received with such acclamations from the natives as on this occasion. Thousands joined in the cheering, and syrens and hooters were heard on all sides. English flags were waved, and the people shouted with pleasure. It was after eight when the crew and their friends arrived back in Ghent. There they were awaited by an enormous crowd, who, when they came in sight, cheered to the echo.

At the prize-giving, which took place in the hotel in the presence of a large number of ladies and gentlemen, gold medals were presented to each member of the crew and to Mr. Bruce, the coach.

Mr. Gregoire addressed the Jesus crew, praising them for their excellent sportsmanship in paying a visit to Belgium, and congratulating them upon their win. Goldsmith briefly thanked the president on behalf of the crew.

A grand banquet followed, at which Mr. Lippens presided. All the chief people in Ghent were there, and the British Minister, Sir Arthur Hardinge, and Sir Cecil Hertslet, from Antwerp, also attended. This did not finish until after midnight. Meanwhile, the large square outside became gradually packed with people, who, in spite of the attractions of a band and fireworks, insisted on seeing the crew. The eight were invited to go on to the balcony and show themselves, and then they had a great reception. The band played "God save the King," the huge crowd and the crew joining in singing the British National Anthem. It was a truly marvellous sight in a foreign land.

Fresh honours awaited the crew on the following day both at Ghent and at Brussels. At both places, as at Antwerp on their arrival, the city authorities turned out to welcome and banquet them.

Few who were privileged to see the race and to partake of the hospitality of their Belgian hosts are ever likely to forget it.

We reprint another account of the race by Mr. C. A. Skinner, the cox of the boat, reprinted from the last number of "The Chanticleer":—

"At the time of the race there was no advantage in the station, and the conditions were almost ideal. Contrary to certain press reports there was quite a fair following breeze, which just 'lipped' the surface at times. The start was not made from stake-boats, but by means of a rope extended across the river, and until the word was given each cox was required to hold a smaller cord attached to the rope. On arrival of the Belgian crew no time was lost, and we were speedily dispatched amid a hush of excitement. Cheering broke out as the Belgian crew seized the lead on the first half-dozen strokes, but then, having set the boat moving in four quick but gradually lengthening strokes, we settled into our stride, and at once drew level. During the rest of the first minute we drew them back, seat by seat, until we headed them by half-a-length. In vain they beat up the stroke—three and four faster than our own—for the Jesus crew quietly maintained its position, without any of the splashing which marked the start.

"At the first signal post, 500 metres, we gave a 'ten' which 'let daylight in' between our rudder and their bows, and with steady confidence this was increased to a lead of nearly two lengths before the bridge was reached. This huge structure, marking

the mile, witnessed the decisive struggle. Under cover of it we raised our stroke slightly, and gave such a 'ten' that we leaped ahead, and I thought our opponents would never emerge from their arch, until at length they darted forth, three lengths behind. Thence they made a great fight, quickening their stroke, and drawing up a little, and in this order we both battled on to the finish, amid an uproar that was little short of deafening.

"The time, 6 mins. 43 secs., was undoubtedly very fast, even considering the conditions, and it has been suggested, with some truth, perhaps, that under pressure the time might have been lessened by some seconds. Our reception was magnificent! Sportsmanship we had expected, but of such enthusiasm for a foreign crew winning the race we had never dreamed."

Cricket. We started the season with eight old colours in residence; examinations, and the absence of Lockhart and N. J. Holloway when playing for the 'Varsity, have frequently prevented us from

playing our best side, but the large number of able substitutes available has been a gratifying feature; two first-rate wicket-keepers, for instance, have appeared in addition to the Captain, H. R. Holme. Among the freshmen P. J. Richardson is a batsman of great promise, and D. Smythe, a fast bowler, played for the 'Varsity against the Free Foresters. Richardson and C. G. Tomlin played in the Freshmen's Match, and in the Seniors' B. H. Holloway and B. W. Pigg. We lost three matches. With the Crusaders we drew, making 329 in the first innings (Stafford 51, Richardson 80, and B. H. Holloway 76): they replied with 326 (F. T. Mann 117), and our second innings produced 104 for six wickets (B. W. Pigg 50). We lost to Trinity on their ground, P. J. Richardson contributing 75 to our first innings total of 100. Trinity made 149 for nine wickets, one of their team not batting, and our second innings totalled 72. With several regular members of our side away, we drew with the Northern Nomads in the last match of the term. To sum up, the batting was generally good, and the bowling sufficient, but there was a great deal of room for improvement in the fielding.

Rugby Football.

This year the College has had the most successful season for some years. There was a much larger number of Rugby freshmen than usual, many of whom proved most useful acquisitions. The foundation of the side's success was laid by the excellence of the forwards. We had a much heavier pack than last year, and throughout the season they played very well, the packing being especially good. Behind the scrum the chief feature has been the brilliance of Lockhart and B. H. Holloway, particularly on the few occasions on which both have been playing. The defence has been very sound, but the attack would have been improved if the centres had drawn their men better, and had we possessed two really fast wings. The number of efficient substitutes has been of great use to us when any regular members of the team have been away.

We only lost two matches, in both cases to King's. The Trinity, Oxford, match resulted in a win for us by the handsome margin of 23—5; we regret that our opponents were unable to put quite their full team in the field. This victory was particularly gratifying, owing to the long series of defeats which had preceded it.

We were represented in the Freshmen's match by H. B. Salmon, M. S. Ray, J. C. Holmes and P. Holman; and in the Seniors' match by J. H. B. Lockhart, A. E. Kitching, C. O. Lilly and R. S. S. H. Stafford. C. H. Reid was unable to play owing

to an injury. Lockhart and Kitching played regularly for the 'Varsity, and both received their "blues."

Athletics.

The chief event in the Athletic world of Cambridge during the last two terms has been the inauguration of the Inter-Collegiate system, and if it has met with as much success in bringing out new talent throughout the University as it has met with in Jesus, we may be justified in entertaining the highest hopes of its efficiency in developing Cambridge athletics in time to come. Amongst us it has produced in our president, H. A. C. Goodwin, a new thrower of the Hammer, who gained his half-blue for this event. A. J. Wright, too, is a prominent athlete who has come to the fore this year, and it is

much to be regretted that his talent as a Long Jumper had not been discovered sooner.

It is, however, for the talent brought to light in the first year that we have most reason to be grateful to the Inter-Collegiate system. T. J. Whittick has proved himself so far invincible at the Quarter-Mile and 100 Yards. G. L. Clark is a Half-Miler from whom we may hope much during the next two years, and R. A. Chandler is a good second to Whittick. These three, together with Howard Banister, represented the College in the relay races on March 13th and 14th, and proved themselves the second best relay team in the University.

We have no reason to be ashamed of our record during the year. We could have wished to have proved ourselves the first College in Athletics; but in Emmanuel we had opponents to whom it was no disgrace to be second. We were unfortunate in not being able to avail ourselves of the services of Banister and Armstrong in the Lent term, and their absence may have lost us several points in the last contest, though it would be rash to say that it lost us the pre-eminence. We also had bad luck in losing our secretary, E. C. Straker, at the beginning of the term.

The Amalgamation Committee has decided that full colours be awarded to all first strings and outright winners in the annual contest with an Oxford College

We must not forget to congratulate H. W. C. Lloyd on his half-blue for Cross-country Running. In the match against Oxford he won the second place among the Cambridge runners.

The draw for the first contest in the Inter-Collegiate matches resulted in a bye for us. The second round was run against Sidney, and resulted in a win for us by 61 points to 39.

The third round, against Christ's, was run off on February 8th: we had much the best of the contest, and secured eight first places out of ten, thereby constituting a record for the whole of the Inter-Collegiate matches. The final score was 65 for us as against 35 for Christ's. All the performances were good, but to Whittick for his winning the 100 Yards in $10\frac{1}{4}$ secs. and the Quarter in 53 secs., and to Goodwin for Throwing the Hammer 108 ft. 5 in., is due the chief credit of the victory.

The final round, against Emmanuel, King's, and Downing, was run off on February 20th and 21st. On Monday we were 4th on the list, but we ended up on Tuesday as second with $24\frac{1}{2}$ points. Emmanuel won with 37 points, King's coming after us with $22\frac{1}{2}$ points, and Downing last with 16. We gained three first places, Whittick in the 100 Yards and Quarter-Mile, and Goodwin with the Hammer; and Manning's high jump of 5 ft. 4 in. deserved more than the 2 points he gained for us in that event.
