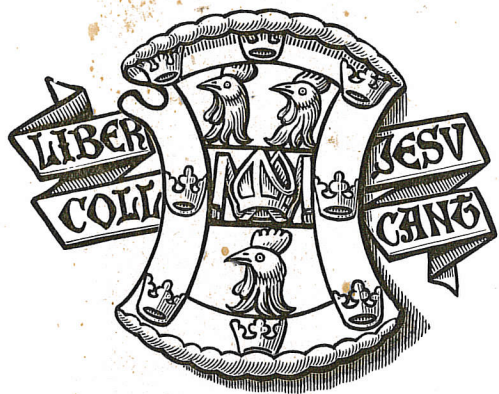

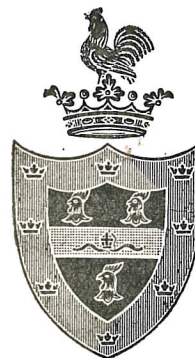

## PREFACE

BY THE MASTER.

---

I HAVE been asked to write a short Preface for this the first Annual Report of the Jesus College Society, a request to which I most gladly respond, for it gives me an opportunity of expressing the sincere pleasure which the founding of the Society affords me, and also of addressing a few words to my numerous friends whose names appear in these pages.

Bearing in mind the main object of our Society as expressed in the first Rule—"To encourage intercourse between old Jesus men, and to keep them in touch with the College and its doings," it is, in the first instance, desirable that all its members should become acquainted with each other in cases where such acquaintance has not already been formed. This evidently necessitates many introductions. Thus suppose the number of members unknown to each other be 300, then 44,850 introductions, involving as many hearty shakes of the hand, would have to be made, a serious business for all concerned. This being so, I venture to suggest a somewhat simpler method of introduction, which, I trust, the Society will recognise as satisfactory, and which I will



now explain. As I believe I may claim the friendship of every member, I trust I may also claim the privilege of making all the above-mentioned introductions, and that I may do this without any tedious formalities. I hereby, therefore, introduce, where necessary, every member to every other, and in thus acting, I well know from personal experience, that I am creating friendships which may develop and mature and prove to be sources of lasting happiness.

“Great souls by instinct to each other turn,  
Demand alliance, and in Friendship burn.”

I have now accomplished the main object I had in view in writing this Preface. Let me give one interesting example of what I have done. I have introduced time-honoured veterans, some of whom are, I am delighted to say, members of our Society, who joined the College before the middle of the last century, whose most attractive daily game outside an occasional row or May term cricket, usually consisted in doing “the Trumpington and Grantchester grind” or other equally interesting “constitutional,” arrayed, perhaps, in top hats and full dress swallow-tailed coats, to the stalwarts of later days clad in simpler garments as they engage in the manifold and fierce conflicts of modern times.

But I have not yet finished my labours as introducer. I feel confident that as the Society becomes more widely known the number of its members will

greatly increase, and I therefore think it prudent to take the present opportunity of introducing to each other all Jesus men scattered over the British Isles and every quarter of the globe.

It is now obvious that the carrying out of the latter part of the important Rule I have quoted will follow as a matter of course, for what will be the subject of conversation on which, for the future, any and every two of the new friends will discourse when they meet? Why, naturally, the College and its doings. Thus their thoughts and hearts will go back to the old rooms, the ivy-clad courts, the Close, the river, and all their delightful associations. Can there possibly be a better way of keeping in touch with the College than this? Further, the annual Report or Calendar, under its most able and competent editors, will be of the greatest value as a guide to the doings of the College, whilst, as time goes on, its interests will in many ways increase, for we shall, no doubt, receive valuable communications from Jesus men in our Colonies and elsewhere throughout the world.

In conclusion, let me add that I heartily wish the Society all prosperity, and hope that it may prove a source of true pleasure and interest to members of the College, past, present and future, resulting in ever-increasing benefit to our beloved and ancient foundation. I feel sure that any further project for the convenience and advantage



of our members will, if practicable, receive most careful consideration by our Committee, while we may rest certain that no improvement in the working of the Society will be omitted so long as we retain the invaluable help of our indefatigable Secretary. Long may he continue to occupy his present position.

Now that we are all linked together let us have faith in the poet's words:—

“Man in Society is like a Flow'r,  
Blown in its native bed. 'Tis there alone  
His faculties expanded in full bloom  
Shine out, there only reach their proper use.”

## R U L E S .

---

1. The Society shall be composed of matriculated Members of Jesus College, Cambridge, who have taken a degree or gone out of residence, and be called “THE JESUS COLLEGE CAMBRIDGE SOCIETY.”

2. The objects of the Society shall be:—

- (a) To encourage intercourse between old Jesus men, and to keep them in touch with the College and its doings.
- (b) To publish and circulate amongst its Members an Annual Report, containing a list of Members with their addresses, and all news of interest about the doings of the present and former Members of the College.
- (c) To ensure the permanence and success of the Jesus College Dinner, held annually in London on the first day of the Inter-University Cricket Match, and to pay the incidental expenses thereof.
- (d) To forward the interests of any College institution.

3. Every matriculated Member of the College who has taken a degree or gone out of residence shall be eligible for election to the Society, and upon election and payment of one guinea shall become a Member of the Society, without being liable to any further expense.

4. The Officers of the Society shall consist of a President, a Secretary, and a Treasurer. The Master of the College shall be the President. The Secretary and Treasurer shall be elected at the Annual General Meeting.

5. The management of the Society and the election of Members shall be vested in a Committee, consisting of the President, Secretary, Treasurer, two resident Fellows of the College nominated from time to time by the Master and Fellows, and sixteen elected Members. At the Annual General Meeting one-fourth of the elected Members of the Committee shall retire from office. The retiring Members shall be those who have been longest in office since their last election, and amongst those of equal seniority the choice, in default of agreement, shall be made by ballot. The vacancies so created shall be filled up at the same Meeting by a majority of the votes of those present and voting. Casual vacancies may be filled up by the Committee, subject to confirmation at the next Annual General Meeting. A Member elected to fill a casual vacancy shall retire at the time when the Member whose place he fills would have retired.

6. The administration of the funds of the Society shall be vested in the Committee, who may invest or otherwise deal with the same for the objects of the Society as they in their discretion may think fit. All investments shall be made in the names of three Trustees to be appointed by the Committee.

7. The Committee shall meet as and when they may from time to time determine; five to form a quorum.

8. The Annual General Meeting of the Society shall be held in London or Cambridge on a day to be fixed by the Committee. At least fourteen days' notice of the Meeting shall be given by the Secretary in such manner as the Committee shall from time to time direct.

9. The Annual Report, containing a list of Members with their addresses, and all news of interest about the doings of the present and former Members of the College, shall be edited by the two resident Fellows who are Members of the Committee, in conjunction with the Secretary, and shall be sent to every Member of the Society.

10. The Committee in their discretion may, and, upon a written request signed by fifteen Members of the Society, shall call a Special General Meeting, the time and place for which shall be determined by the Committee. At least fourteen days' notice of such



Meeting, stating the subject, shall be given in such manner as the Committee may direct.

11. If it appear to the Committee that the conduct of any Member of the Society is such as to render him unfit to remain a Member thereof, it shall be in their discretion to call a General Meeting to deal with the matter, and, in the event of its being decided at that Meeting by two-thirds of the Members present and voting that such Member be expelled from the Society, he shall thenceforth cease to be a Member and forfeit all right to or claim upon the Society or its funds.

12. The Rules of the Society may be altered, but no alteration shall be made except at a General Meeting and by a majority of two-thirds of those present and voting, and unless notice of the proposed alteration has been stated on the notice calling the Meeting.

## FORMATION

### OF THE

## Jesus College Cambridge Society.

---

THE JESUS COLLEGE CAMBRIDGE SOCIETY took its rise in the institution of an annual dinner, which has been held since 1897; and it originated not in Cambridge but in London. The dinner was planned on the first day of the Inter-University Cricket Match in the previous year, when fourteen Jesus men dined together at the Junior Athenæum Club, and agreed that they would endeavour to start an Annual Dinner of old Jesus men. Six dinners have been held, the first at the Café Monico, the second at the Whitehall Rooms, and the last four at the Hotel Cecil. In 1901, owing to the death of Her Majesty Queen Victoria and the war no dinner was held.\* On every occasion the Master of the College took the Chair, and long may he continue to do so! But in 1903 it was felt that something besides a

dinner should be arranged to bind Jesus men throughout the world together. The dinners, successful as they had been, depended on the efforts of individuals, notably on those of Messrs. C. Gurdon, J. W. Dickson, and Wanklyn, and a more permanent organisation was needed. Accordingly it was proposed at the dinner that a Society should be formed consisting of Jesus men. This suggestion was unanimously adopted, and a Committee was formed to carry it out. Mr. C. Gurdon, the Rev. F. J. Foakes Jackson, Mr. J. W. Dickson, with Mr. Henry Menzies, as Secretary, were requested to report on the practicability of the scheme to a general meeting of Jesus men convoked for the purpose in London. A circular inviting support was issued to all old Jesus men whose addresses could be found. Suggestions were also invited as to the best means of making the Society effective. No less than 1,039 circulars were despatched, 40 of which were returned as undelivered by the Post Office. Answers have been already received from upwards of 400 men, promising support to the Society.

The Committee met in London and Cambridge, and, after giving careful attention to the various suggestions made in reply to their circular, they proceeded to draw up rules for the consideration of the general meeting. The Committee unanimously decided on the following points:—(1) That an annual subscription would involve unnecessary



trouble in collection, and that it would be better to admit members on a single subscription of £1 *is.* for life. (2) That in return for this members should be furnished with an annual report of the doings of the College and of old Jesus men generally, as well as with a list of those belonging to the Society with their addresses. (3) That, despite the fact that many men complained that July was not a convenient time for the annual dinner, it appeared that in no other month so large a gathering of Jesus men was possible, and consequently the dinner must continue to be held on the first day of the Oxford and Cambridge Cricket Match.

The General Meeting was called for December 15th, 1903, at the Hotel Cecil. Seventy Jesus men were present, and, to the satisfaction of all, the Master took the Chair. Letters were received from 110 Jesus men regretting their inability to attend. With such support it was decided that the formation of Jesus College Cambridge Society was not only desirable but practicable.

The following resolutions were passed unanimously:—

RESOLUTION I.—That the Jesus College Cambridge Society be, and hereby is, founded.

RESOLUTION II.—That the Rules of the Society be adopted. See p. 11 of this Report.

Proposed by the Master.

Seconded by the Rev. Canon F. J. Foakes Jackson.

RESOLUTION III.—That the Officers of the Society be duly elected. See p. 5 of this Report.

Proposed by Mr. Charles Gurdon.

Seconded by Mr. A. F. C. Luxmoore.

RESOLUTION IV.—That this Meeting do pass a vote of thanks to the Master for kindly coming to preside at this Meeting.

Proposed by Dr. Macan.

Seconded by Mr. P. C. C. Francis.



## REPORT OF THE EVENTS OF THE YEAR

1903—1904.

---

THE first Report of the doings of the College must, perhaps of necessity, be somewhat incomplete. In future years it is to be hoped that Members of the Society may send information to the editors about themselves or other old Jesus men, thereby enabling them to give fuller and more interesting reports as time goes on.

The List of Resident Members of the University, published by the "Cambridge Review," contains the names of twenty Jesus men of or above the degree of M.A., thirty-three B.A.'s and third year men, thirty-six second year, and forty-two freshmen. From this it will be seen that the College is labouring under the disadvantage of having less third year men than usual.

It has consequently had hard work to keep up all its different activities, and it is a matter for no small congratulation that the College has maintained a high position in nearly every single department among the larger colleges of the University.

It is first our melancholy duty to allude to the losses our College has sustained by death. No less than three Fellows have passed away during 1903. The death of Hugh Shield, K.C., leaves a gap which is not easily filled. A kinder man or truer friend never lived, nor were his services to the College inconsiderable. He was frequently in Cambridge, where he exercised a genial hospitality, bringing many men of mark to visit him, especially when he represented the town in Parliament. He presented to the College a fine silver cup to commemorate the occasion of five Jesus men rowing in the winning crew against Oxford in 1876, and the pictures of Lawrence Sterne and Coleridge, in the College hall, are his gift. He was some years Bursar. Mr. Shield was a Bencher of Gray's Inn as well as a Fellow of our College, and was much beloved in both societies.

Thomas King, C.B., who died in Cornwall, was long a Fellow of Jesus, and at one time lectured in Mathematics. He held a high place in the Education Office and had just retired on a pension, with the Companionship of the Bath. Both he and Mr. Shield left benefactions to the College.

In Romril James Robert Goffin the College lost one of its most promising young men. His career was a brilliant one. A first-class man in History and Senior in the first part of the Law Tripos, he won



the George Long Prize in 1897, the Yorke Essay in 1890, and was elected Whewell Scholar of International Law in 1897. His contributions to the Legal Journals had already attracted considerable attention. He died of tuberculosis after a long and painful illness, and we regret to say that his brother, Sidney Goffin, who nursed him in his illness, has been himself in a very precarious condition. Happily he is now recovering and, it is to be hoped, will soon return to his work at the War Office.

Three former Fellows of the College have also died—the Rev. Robert Alfred Rackham, Rector of the College Living of Whatfield, at the ripe age of 89; the Rev. James Robertson, Vicar of the College Living of Whittlesford; and the Rev. Thomas Charles Durham, Hon. Canon of Carlisle. Mr. Robertson was bracketed Second Classic in 1859, and was an Assistant Master at both Rugby and Harrow, and Head-Master of Haileybury. He was a most brilliant scholar, of whom the College was justly proud. In the Rev. C. L. Acland, Vicar of the College Living at All Saints', Cambridge, since 1892, the College sustained a great loss. The Rev. A. B. Sole, Vicar of S. Andrew's, Winchester, one of the first, if not the first, to join our Society, died in December; and we have also to record the loss of the Rev. S. A. Thompson Yates, a generous benefactor of Education in Liverpool. Finally, we regret to have to announce the death of Mr. J. Hilton Ridley, one of our mos

distinguished athletes in the "Sixties." He won the quarter mile against Oxford in 1868, and rowed at Putney in 1869 and in 1870.

A memorial to those Jesus men who fell in the South African War is to be erected in the Chapel. So far as we know they were but four in number, namely, MacDonald, Swanston, McLaren, and Baille-Guthrie.

The Master and Fellows elected a Fellowships. Fellow in December, who may certainly be regarded as one likely to add lustre to the College. Mr. William Ravenscroft Hughes was fifth Wrangler in 1902, and was placed with two other Wranglers in the 1st Division of the 1st Class in Part II. of the Mathematical Tripos. Mr. Hughes won distinction as a speaker at the Union, and is now reading for the Bar.

The College is poorer for the loss of two distinguished Members; Dr. Mason, Lady Margaret Professor of Divinity, and a Fellow since 1896, was elected Master of Pembroke. His first thought during the tenure of a Fellowship at Jesus seemed to be how he could help the College, and he gave us as a parting present many very valuable new trees for the Grove, a gift following other generous donations. Our Director in Legal Studies, Mr. W. R. Rendell, was elected a Fellow of Trinity Hall, and many Jesus men will envy an old rival in having deprived



us of so useful a man. Mr. Rendell has been for some time a Lecturer at Pembroke, drawing very large classes to hear him, his reputation as a teacher of Law in the University being of the highest.

**Benefactions.** The Widow of the Rev. J. S. Lillistone, late Fellow of the College, has left the sum of £2,000 to the College to endow one or more Scholarships for the Sons of Clergymen of the Church of England.

**Honours.** The intellectual distinctions obtained by Jesus men in the University in 1903 were perhaps somewhat below the average of the past few years. Mr. Hughes, as we have said, did brilliantly in Part II. of the Mathematical Tripos; and in Part II. of the Natural Sciences T. Hewett was placed in the 1st Class for Zoology; T. Dakin was 12th Wrangler, and C. C. Garbett a 1st Class 3rd Division in Classics; H. G. Wood and W. K. L. Clarke, who were placed in the 1st Class, Division II. in the Classical Tripos of 1902, have been repeatedly successful in their Theological studies, and were highly commended in several Prize and Scholarship Examinations; Mr. Wood gaining the Crosse Scholarship and being highly commended in his work for the Carus Greek Testament Prize, and Mr. Clarke being Carus Prizeman, and highly commended for the Crosse Scholarship. The Jeremie Septuagint Prize fell to Mr. Clarke, Mr. Wood having won it the year before.

A Winchester Reading Prize for 1904 has been won by a Lady Kay Scholar, H. R. Lonsdale; and H. G. Wood has carried off the Lightfoot Scholarship. Two members of the College were successful in the Examination for the India Civil Service this year, H. Fyson and E. B. Maundrell. A College Prize has been founded in the United States by the descendants of the Rev. John Eliot, the famous Apostle of the Indians in the seventeenth century, and was won this year by W. K. L. Clarke, B.A.

Several books have been published in the past year by members of the College, **Books.** and though Mr. Gray's History of Jesus College appeared in 1902, it must stand first on our list. It is published by F. E. Robinson, and is one of the "Cambridge College Series." It is, perhaps, not entirely due to partiality when we pronounce it as good as any in the series or in the companion volumes on Oxford Colleges. Indeed, it could not be better. Mr. Gray has been President of the Cambridge Antiquarian Society, and has made a special study of his subject. Every Jesus man should read his book.

A very excellent series of handbooks for the Clergy is being edited by the Rev. A. W. Robinson, B.D., whose "Personal Life of the Clergy" has had a large circulation.

The Rev. F. J. Foakes Jackson, B.D., was Hulsean



Lecturer in 1902-3, and has published his lectures in a volume called "Christian Difficulties in the Second and Twentieth Century" (Arnold), and C. J. B. Gaskoin, who won the Hulsean Prize Essay in 1899, has now brought out an enlarged edition of the successful essay, entitled "Alcuin, His Life and Work" (University Press).

Mr. Oliver Ready, who has been long in China, has written a most interesting account of his experiences there: "Life and Sport in China" (Chapman and Hall).

Two Fellows of Jesus, Mr. Welsh and Mr. A. W. Siddons, served on the Syndicate appointed to consider the methods of the late Professor Eucleides of Alexandria, Egypt. The works of that geometrician being pronounced hardly up to date, Mr. C. Godfrey, Senior Mathematical Master at Winchester College, and Mr. A. W. Siddons, Mathematical Master at Harrow School, undertook to supplant them. "An Elementary Geometry, Practical and Theoretical" (Camb. University Press) is the result of their labours. The word "Resurgam" has now been obliterated from Euclid's tomb.

An excellent book on birds has appeared by A. J. R. Roberts, a Football Blue (B.A., 1903); and J. M. Edmonds, assisted by a colleague from Oxford, has given to the world an edition of the "Characters of Theophrastus" (Blackie and Sons). Mr. Foakes

Jackson has also published a Biblical History of the Hebrews, and Anthropologists in all countries are hoping for a book by Mr. Duckworth on their interesting subject.

In the forthcoming volume of Cambridge Theological Essays, out of fourteen essays, three are to be by Jesus men (Messrs. Duckworth, A. W. Robinson, and Foakes Jackson), and Professor Nairne is expected to give the world his commentary on the Epistles to the Hebrews early next year.

Captain Mark Sykes has produced an excellent book on the blessings of Turkish Misgovernment, entitled "Dar-ul-Islam: a Record of a Journey through Ten Turkish Provinces" (Bickers). It is a work full of sympathy for the East, and contempt for Western methods, and is enlivened by a humour rarely found in travel-literature.

We must not fail to notice the appearance of a book on Napoleon's captivity, by Mr. R. C. Seaton, late Fellow of the College, nor the interesting series of articles by the Rev. A. C. Jennings, on the Abbé Loisy, in the "Churchman" Magazine.

The Scholars elected for 1904, if few in number, are very promising. It is now <sup>Scholars.</sup> customary for the College to join with Pembroke, Gonville and Caius, King's, Christ's, St John's and Emmanuel, and in this formidable combination our



tutors had almost the pick of the classical and mathematical men for the eighty pound scholarships.

Livings. The three College Livings vacant by the deaths of Mr. Rackham, Mr. Robertson, and Mr. Acland have been filled by former Scholars of the College. Whatfield was presented to the Rev. E. A. Lane (B.A. 1886), Whittlesford to the Rev. R. Letts (B.A. 1880), Vicar of Scawby, Lincolnshire, and All Saints', Cambridge, to the Rev. T. W. Crafer (Lady Kay Scholar and Carus Greek Testament Prizeman, 1894). It may be of interest to many members of this Society to know what Livings are in the gift of the College and their respective nett values (approximate), so we subjoin a list:—

The value of the College Livings has been much

affected by the Agricultural Depression, and as all of them are in the country, except All Saints' and St. Clement's in Cambridge, none of them have escaped. It is satisfactory, however, to be able to say that the Parsonage Houses are, as a rule, not too large and in good condition.

For the sake of information, an extract is given from the 34th of the College Statutes "Of presentation to Benefices":—

In presenting to the several Benefices in the patronage of the College, the Master and Fellows shall have regard in the first instance to the Master and Fellows, the former Fellows of the College, the Chaplains or former Chaplains, and other present or former officers and former Scholars of the College, regard being had to length of service in the College.

There are numerous Societies in existence College Societies. in the College, but many of the old ones have disappeared. Where, for example, is the Cranmer, the College Debating Society, the Halliwell, the Coleridge? They have vanished; but others have sprung up in their places, or rather they have reappeared under new names. But two clubs are still in existence, the Radegunds and the Natives, and long may they flourish! The Shakespeare Club is now known as the Stratford, and the Scholars and a few others have a Debating Club (known as the "Farrago's") to discuss deep problems. A Theological Society, which meets in the Dean's rooms, or in a lecture room, when a magic lantern is in requisition,



has been addressed by many distinguished members of the University, notably by the late Sir George Stokes.

College  
Mission. The College Mission was moved from St. Bartholomew's, Smithfield, to Christ Church, Rotherhithe, and under the Rev. C. D. B. Somerville, an old Jesus man, did excellent work in a most unsavoury slum. Mr. Somerville is now leaving the parish, and the old houses are making way for model dwellings, so the work cannot be continued; but many are resolved that there shall still be a College Mission. The Bishop of Rochester, it may be said, is exceedingly anxious that any work undertaken by the College should be done in South London.

Rowing. The College boats in 1903 were not very successful. The 1st Lent boat fell from third to sixth, and the 1st May boat went down three places. It must be remembered that the May boat of 1902 was unusually fortunate in having so energetic a Captain as F. C. Aldous, and in securing the services of T. Drysdale, who, by the way, rowed in the winning Grand Challenge Crew at Henley in 1903. Considering the size of the College, and the fact that the Club lost many of its best oarsmen, 4th on the River was a hard place to maintain last year. But the second boats both went up, and, fortunately, much spirit was shown in endeavouring to make up for the disasters of the season. G. S. Oddie was elected Captain in October,

and has since worked indefatigably at coaching the Freshmen in the Michaelmas term, and has been ably backed up by his officers. The usual results of keenness followed.

In the Lent Term we had three boats. The Third boat won all its heats in the getting-on races, and bumped Clare III., thereby securing a place on the river. In the actual races three bumps were made, and the crew got their oars. In the Second Division, Jesus II. made two bumps, and the first boat starting at 6th in the First Division went up to third. So in all nine bumps were made by Jesus boats. Oddie rowed for some time as No. 2 in the University boat, and was offered the place of ninth man, but owing to his impending Tripos he decided not to go with the crew to Putney. The "May" boats are said to be promising.

It is to be feared that the style of rowing is not good, indeed it is bad throughout the University. We believe that if the J.C.B.C. could but secure the services of an old Jesus man to teach them the way to use long slides in the way our crews used them in the early eighties it would not be impossible to recover our lost place at the Head of the River. The condition of University rowing is most serious, and unless something is done oarsmanship will become a lost art.

The Eleven for 1903 was a fair one, but as J. W. Marsh and F. B. Roberts were often

required to play for the University, the full team was seldom represented. T. E. Manning kept wicket in the Freshmen's Match, and also for the Twelve v. the Sixteen. We were represented in the Seniors' Match by J. W. Marsh, J. F. Marsh, F. B. Roberts, and A. M. Bashford. J. W. Marsh played in most of the Trial Matches, but he was not among those chosen for Cambridge; and only F. B. Roberts represented our College in the *débat* which Mr. Dowson and his friends met with at Lord's against Oxford. For 1904 some very useful Freshmen were discovered. In the Seniors' Match J. F. Marsh acted as captain to the winning side, on which were two Jesus men—H. Mainprice and T. E. Manning. Marsh's second innings of 113 won the match, while Mainprice's fielding as "third man" was particularly good. Perhaps it is hardly necessary to remind our readers that three first-class county elevens are being captained by Jesus men, viz., Somerset by S. M. J. Woods, Middlesex by G. McGregor, and Notts by A. O. Jones.

Rugby  
Football.

The Rugby Football Team, whilst maintaining a place among the better College Fifteens, was hardly as successful as usual owing to the extreme lightness of the "forwards." The back division, especially the "halves," was as good as any in the University. Mainprice, Rawes, Hoskyns, and Gardiner were worthy of a place in any team. Mainprice played against Oxford for the second time, and has been elected University Captain for 1904.

The season of 1903 ended with Jesus <sup>Association.</sup> being head of the League, after a series of matches in which the College was absolutely unbeaten. In the match with Christ Church, the best College team at Oxford, each side secured a goal. The greatest credit is due to J. W. Marsh, the Captain, whose keenness really made a team without "blues" the best in the University. We could hardly expect to be equally successful in 1903-4, but we finished fourth in the First Division, a satisfactory performance considering that we had lost some excellent material and had no Freshmen quite capable of filling the places of those who had gone down.

Hockey has apparently come to stay, and <sup>Hockey.</sup> the way the Close has been cut up by it gives promise of some very lively cricket this season. A League has been formed, and Jesus was originally placed in the Second Division. This year owing to the excellent play of F. B. Roberts and Rawes, the team won all its matches except one, which was drawn, and it will henceforth appear in the First Division.

We were only represented against Oxford <sup>Athletics.</sup> by A. S. D. Smith, and he had unfortunately dislocated his ankle whilst in training, so he did no good in the three miles. As he holds the record of the London Athletic Club for ten miles, and has, though an English-speaking Saxon, become a Welshman by winning the half mile championship for the



Principality, he would have been a useful man in the sports had he been fit.

Jesus won the sports against Trinity College, Oxford, with ease, thus getting even with that College, which completely beat us at Rugby Football.

In the College Sports C. C. Garbett won the Victor Ludorum Cup presented by Mr. Thornton, being successful in the Weight, Hammer, and High and Long Jumps.

We sincerely hope that it may be our lot to give in future years an even better record than the foregoing; yet the year which has witnessed the formation of the Jesus College Cambridge Society, can never be other than a memorable one, since it marks the beginning of a federation of old Jesus men in support of the College. It is gratifying to notice how many names familiar to senior members of the College now appear amongst the undergraduates, and the sons, brothers, and nephews of those who were celebrities in their time are reviving memories of old triumphs. In such is much of our hope for the future fixed, and we can repeat with some confidence the old aspiration

## The College Mission.

BY THE REV. C. D. B. SOMERVILLE.

SINCE the year 1885 the College has been engaged in Mission work, first in the parish of St. Bartholomew's, Smithfield, where work was carried on for twelve years and only relinquished on account of the diminishing population. Latterly, since 1898, it has helped in the work of the parish of Christ Church, Rotherhithe, S.E.

The district chosen was a very poor one, situated on the south side of the river about  $1\frac{1}{2}$  miles below the Tower Bridge. Here a house was taken and opened by the Dean, the Rev. F. J. Foakes Jackson. It was decided to guarantee £50 a year for three years, and so to start at first in a tentative way. The money was intended to pay the rent, rates, and taxes of this house, to provide a caretaker, and meet the expenses of a club for working lads. To do this, even in the most economical fashion, the money provided proved inadequate; and before long it was found that fully £75 must be subscribed to keep things going. This has been done and the work has progressed. A Lads' Club, numbering about 50 or 60, the ages ranging from 13 to 18, has been formed, and a Band of Hope for children containing about 150 members.

From a Cambridge point of view the Mission has provided a means by which the men of the College can help their poorer brethren—

- (a) By coming and staying at the College House (terms 12s. per week) and assisting in the Club and Mission work. This has been done notably by Messrs. Garrad, Clarke, Fulford, H. J. Mowll, and E. W. Mowll, as well as by other members of the College.
- (b) By pecuniary help, which almost all the resident and several non-resident members have given.

The Annual Meeting in the Common Room has been usually attended by nearly every one in College. From a Rotherhithe point of view the Mission has proved a source of pleasure and benefit to the lives of many children and young people in the neighbourhood. The whole tone of the children has changed for the better, and when a new family comes into the district, though often more respectable in outward appearance, their language and behaviour is far worse than that of our shoeless youngsters. The Lads' Club has also, we trust, done a good work though the result is not so apparent; it has, at any rate, kept the boys out of the streets and provided enjoyment on many a cold night.

Much good undoubtedly has been done, but now



a crisis faces the Mission. The old streets and houses which formed the *raison d'être* for the establishment of the Mission, and which were marked black—the worst colour—in Sir Charles Booth's map, have been pulled down and most of the inhabitants scattered to the winds. New buildings, it is true, will be erected, but it is scarcely probable that they will be occupied by the same class of tenant. What is the College to do? That is the question that at present is being discussed by the Mission Committee.

That a Mission is desirable is generally recognised, for apart from the benefit to the neighbourhood in which it works, it gives the undergraduate the opportunity of seeing for himself the conditions under which his poorer brethren live—under which they are even happy and contented. Several have said to me, "I only wish I had come down to the Mission sooner." I, for my part, have often thought it would have been of great advantage for some of our statesmen and theologians to have worked in a College Mission. For it may be said with truth to be an indispensable factor in University life: practice is added to theory, the conditions and needs of the people are realised, and the Christian religion is seen to be the one remedy for our social evils.

If the Mission is to be moved, which the Committee seem strongly to recommend, it should be to a district which can eventually become separate from the parish—with its Missioner paid and

appointed by the College. The cause of failure in the past (if we may call it failure when such good work has been done both in Rotherhithe and Smithfield) has been that the College has started work in a parish where the separation of a special district was impracticable, so that the work has been exposed to the unsettling influences of inevitable parochial changes. While the work locally has been of much value, yet the College has from time to time had to face the great difficulty of making a new start in some other neighbourhood.

At the present juncture the co-operation of old Jesus men is most urgently needed, both in giving advice and in the necessary subscriptions.

Hitherto the work has been mainly carried on by the resident members of the College, but a larger scheme, such as is necessary to ensure success, is beyond their unaided efforts. The time has come for a united effort on the part of all, that the work may be of a permanent character and worthy of the name of Jesus College.
